The Board of Trustees may authorize the sheltering of limited numbers of a specified type of livestock in any zone district subject to the following limitations.

1. The property owner shall submit a written application to keep livestock.

At a minimum, the application shall indicate:

A. Specific type of livestockB. Specific number of livestockC. Lot or parcel acreage

- D. A site plan indicating the location and type of fencing and housing.
- 2. A petition signed by the neighbors of adjoining properties indicating their approval or disapproval of the application to keep livestock.
- 3. The application will be reviewed for compliance with animal units, and neighbor acknowledgment and support of the application. If animal unit criteria are met and all neighbors are in support of the application, Town Staff shall issue a permit.

In the event that all neighbors are not in support of the application, a meeting with the Board of Trustees shall be scheduled and the Board of Trustees shall approve or deny the application at a public meeting.

4. In the event the Board of Trustees approves the application, the authorization to keep livestock shall be permitted to the individual applicant and shall not be transferable.

The Board of Trustees may revoke said authorization without notice and without cause and the property owner gains no vested rights through such authorization. (Ord. 01, 2011)
