Mr Julius requested Board approval of a Special Events Liquor License application for American Legion, Post 86 to hold a dinner and dance at the Collbran Auditorium. The event is to raise money for local veterans, they will serve beer and wine with dinner. Marshal Appelhanz has no concerns with this event and recommends approval. Town Staff recommends approval.

#### Town of Collbran Mid-Year Financial Report

#### Proclamation Declaring the Name of Collbran to be Santa Rosalia

Mayor Evans read a Proclamation declaring the Name of Collbran to be Santa Rasalia for the week of September 2, 2018 through September 7, 2018. Sylvia Spangler from the Plateau Valley Historical Preservation Society was on hand to accept the Proclamation. Ms. Spangler also gave an update on the Santa Rosalia Celebration.

Resolution No. 7, Series of 2018 – A Resolution of the Town of Collbran, Colorado, Establishing the Locations for Posting Official Public Notices Within the Town of Collbran

As discussed at prior meetings, we need to designate our posting places for Public Notices. Town Staff is suggesting a new bulletin board in front of the Collbran Auditorium, the bulletin board in front of Town Hall and a bulletin board at Lilac Park.

There was discussion to keep moving forward on the work we had started on the Sign Code.

The Board discussed the retirement of Tom Kachin and what staff was doing to be proactive in finding a replacement.

Mayor Evans had praise for Melonie Matarozzo and Marshal Appelhanz.

#### **Town Administrator**

Admin. Farrar discussed the Administrator Transition plan between he and Elyse Casselberry. Mr. Farrar will stay available for as long as his services are needed to make the transition as smooth as possible. There are a few projects he would like to wrap up before he leaves.

Admin Farrar gave an update on our downtown improvement project.

Admin Farrar brought up that an Ammendment to the Land Use Code may be in order regarding sheds.

#### Town Marshal

Marshal Appelhanz distributed his monthly report to the Board. Marshal Appelhanz told the Board that he is trying to finish setting up patrol vehicles. He mentioned the Town will advertise for the position of Deputy Marshal again. He was asked to explain the ALICE training he attended.
