INSTRUCTIONS FOR PETITION CIRCULATORS**

**READ THE WARNING** at the top of each page.

**TO SIGN A PETITION**, a person must be an eligible Town of Collbran voter as shown by the records of the Mesa County Clerk and Recorder.

A person **CAN SIGN ONLY TWO** candidate petitions for the office of Trustee and **ONLY ONE** candidate petition for the office of Mayor.

A petition circulator **MUST PERSONALLY OBSERVE** every eligible voter who signs his/her petition. (Petition cannot be left on counters or desks unattended.)

There can be only **ONE CIRCULATOR FOR EACH PETITION**.

The **CIRCULATOR MUST WRITE HIS/HER NAME** on the bottom of each page in the space provided

**DO NOT TAKE APART A PETITION.** If the original staples are removed, the petition **WILL NOT** count and will be invalid.

Make certain that all required information is complete. **A SIGNER MUST USE THE ADDRESS WHERE HE/SHE IS REGISTERED TO VOTE.**

The petition form has four spaces that each signer must complete, being signature, printed legal name, residence street address, and date. **DO NOT ABBREVIATE ANY WORDS.**

**A POST OFFICE BOX IS NOT A PLACE OF RESIDENCE.** Building number and street name **MUST** be provided. Do not abbreviate any words.

If a **SMALL CORRECTION** is made, the signer should initial the change. If a **LARGE CORRECTION** is required, the signer should cross out the incorrect information and proceed to the next line.

If a signer is disabled and needs assistance, a **THIRD PARTY** should provide that assistance. **THE CIRCULATOR CANNOT ASSIST THE SIGNER.** The person providing assistance shall both **SIGN AND STATE ON THE NEXT AVAILABLE LINE THAT ASSISTANCE** was given.

**NO PERSON MAY SIGN FOR ANOTHER.**

**EVERY VALID SIGNATURE COUNTS!** A petition does not have to be filled, but it does have to be correctly notarized as noted below. **TEN (10) VALID SIGNATURES** are required to conform to the Municipal Election Code.

When the circulator has finished collecting signatures, he/she should take the petition to a Notary Public.

The attached affidavit should be signed and dated **IN THE PRESENCE OF THE NOTARY PUBLIC**, who will then notarize the affidavit.  
**(NO EMPLOYEE IN THE CLERK'S OFFICE WILL NOTARIZE ANY PETITIONS)**

**NO ADDITIONAL SIGNATURES CAN BE COLLECTED** after the affidavit has been notarized.

**MUNICIPAL ELECTION NOMINATION PETITION**

Candidates must meet the following criteria pursuant to **C.R.S. 31-10-302**

for the Town of Collbran to be voted at the Recall Municipal Election to be held on the 7th day of April, 2026.

**CRS 31-4-504(4) Nomination** Petitions may be circulated and signed beginning on the 1st day after the governing body sets the date for the Recall Election (January 20, 2026) and shall be filed no later than twenty (20) days after the date of the recall election is set (February 9, 2026).

**CRS 31-4-504(4) Petitions** shall be filed with the clerk no later than twenty (20) days after the recall election date is set by the governing body.

**C.R.S. 31-10-302(2)(c)** Each petition shall be signed by a minimum of TEN registered electors. The Town Clerk shall validate all signatures on a petition.

**C.R.S. 31-10-305** All petitions of nomination and affidavits that are in apparent conformity with the provisions of section 31-10-302, as determined by the clerk, are valid unless objection thereto is duly made in writing within three days after the filing of the same. In case objection is made, notice thereof shall be forthwith mailed to any candidate who may be affected thereby. The clerk shall decide objections within at least forty-eight hours after the same are filed, and any objections sustained may be remedied or defect cured upon the original petition, by an amendment thereto, or by filing a new petition within three days after the objection is sustained, but in no event later than the sixty-fourth day before the day of election.

**C.R.S. 31-10-302(2)(c) SIGNATURES OF PETITIONERS** (Petitioners MUST live within the Town limits. Some "Collbran" addresses are not within the Town of Collbran. Please check the Mesa County Assessor's website for additional information.

**C.R.S. 31-10-302(5)** No registered elector shall sign more than one nomination petition for the recalled office of Trustee.
