4. Administrator Matarozzo created a folder in the Google Drive "Board Education" CML put out publications that teach their training for board members, their training for Town employees and Town staff. It reminds the board of their roles. Will be putting new items in there to be reviewed.
5. Mayor Todd says kudos to all. He is also very pleased that Mesa County has partnered up with us to do some paving.

7. Mayor Todd sat in on a call with Melonie and Karla in regards to broadband. There are many stakeholders- PV School, Medical Clinic, Fire Department, Mesa County Janet Rowland and Cody Davis, Vega State Park, DOLA who all join in on these phone calls. Asked for a 50/50 grant and asked for matching funds for that of \$25,000. As a total we are going to have to come up with \$84,000 and that was met today. We will have a shovel ready project by the end of summer.
