VII. Plateau Valley School District Presentation

Trevor Long presented information on the BEST grant that was awarded to PVS. It was the largest amount of money awarded to one school in the amount of \$27 million. Mr. Long explained that we were given such a large grant because the school is in such poor condition. Mr.Long explained that if the school were to be shut down for an illness or another plumbing leak, there is a risk that the school would not be able to reopen and the community's children will be forced to attend school in DeBeque or Palisade. Mr. Long also explained the bond levy that would be required of residents to help fund the rest of the \$66 million project that would be the new school. If approved, construction would be completed in phases in such a manner that would not disrupt regular school year classes.
