- a. Administrator Matarozzo explained that it had been recently moved. Public Works was really busy trying to clear the road and that is where it was placed in the time being. It has been moved and they will take caution when piling it back up on the corner.
- 2. Trustee Dalrymple asked about the ordinance in regards to businesses being responsible for the clean up of their sidewalks.
 - a. Administrator Matarozzo brought up that the ordinance wasn't necessarily new and that it had been in the Town of Collbran's municipal code for a while. The prior discussion on the ordinance made it to where code enforcement could write tickets. With that being said, we will not start with issuing tickets, we will start by notifying business owners and reiterating the code.
- 3. Trustee Melnikoff asked about the signs for the Auditorium.
 - a. Administrator Matarozzo did order 6 signs, 3 for each side of the Auditorium. They gave us a 7-14 day range before they are expected to be here.
- 4. Trustee Melnikoff asked when the board election packets were available for pick
 - a. Administrator Matarozzo stated they became available today for pick up.
 - b. It was posted in the PV Times and we can add it to the Community Page for the public to be aware of.
