VI. Mayor Todd completed the First Reading for the adoption of the 2018 International Energy Conservation Code - Ordinance No. 2, Series 2022.

Town Administrator will be sitting on several committees with the county to approve new energy ordinances. Most new ordinances will apply to new construction projects or structures in town.

## VII. Guidance and Motion to Accept Proposal for Library Roof Repair

The Stockman Bank Building is a structure owned by the Town and we are responsible for the building and its necessary repairs. The Board was presented with three options for roof repair:

- A) 1 year leak proof warranty \$3,200.00
- B) 10 year leak proof warranty \$10,000.00
- C) 20 year leak proof warranty \$20,000.00

After discussing the possible options, the Board of Trustees has agreed to allocate funds from the Town's contingency fund to repair the roof and in the Board's words, "Do It Right."
