VI. Mesa County Building Department Manager Darrel Bay to Discuss Ordinance 2

Mr. Bay explained that the new ordinances being put in place have been passed down directly from the Federal Level. The State of Colorado has to comply with these new energy ordinances to be able to continue to receive federal fundings in the future. He explained that the Mesa County Board has adopted the 2018 energy code instead of the 2021 energy code, as it makes

more sense for the Grand Valley at this time; Noting that the valley doesn't have the resources or supplies currently to adopt the 2021 energy code to the fullest extent. Mr. Bay also discussed several topics that the new energy code will pertain to including insulation levels in windows and walls, as well as inspections regarding air leakages in new homes or additions to existing structures.
