## XI. Trustee (Informational and/or items for future agenda)

- 1. Trustee Appelhanz asked about fireworks for the 4th of July.
  - a. Administrator Matarozzo stated that the fire department will not have to take the certification class as the fireworks we have looked into don't go as high.
  - b. There is still concern for another dry year as we don't have as much moisture as we should have.
  - c. Trustee Appelhanz was wondering if there could be an alternatives
  - d. Administrator Matarozzo did mention laser shows and drone shows, but both are pretty pricey.
- 2. Trustee Appelhanz also asked about a speaker system for the rodeo grounds.
  - a. Administrator Matarozzo said that is up to the Rodeo Committee as far as renting or borrowing for the 4th of July. We are not replacing the sound system.
- 3. Trustee Melnikoff piggy backed on the sound system asking if we can work with whoever the Rodeo Committee gets with as well to get more speakers set up down the street for the 4th of July parade.
- 4. Trustee Melnikoff mentioned the COVID Bus was very beneficial again.
  - a. Public Works did such a good job getting the parking lot ready as far as clearing as much ice off as they could.
- 5. Trustee Dalrymple asked about the bridge on the end of Main Street
  - a. Administrator Matarozzo said we did get the inspection of the bride completed, but do not have the report back. It was one of the items we highlighted with the engineers, but we need to have the report back before we can move forward with that.
- Administrator Matarozzo mentioned that AGNC has a mini grant program for communities and she can look into them for possibly getting speakers or something for Main Street.
  - a. We could definitely benefit from this as we have many events down Main Street.
