Staff was asked about moving the asphalt from the tennis court that has been readied for transport and when we may be able to move it off site. Staff is working with Mesa County to possibly get a grinder to reuse the asphalt in other areas.
- 2. Discussion around possible funding opportunities for fire mitigation that Staff is researching.
- 3. Had a discussion regarding a third officer and if staff was actively recruiting. At this time we are not. During the 2022 Budget prep it was decided to fill the 3rd position if we had an MOU in place with the school and they were reimbursing for part of the salary, we do not have that in place at this time. We will add it to a future Agenda for further discussion.
- 4. Mayor Pro-Tem Kris Melnikoff attended the Emergency First Aid Trauma Medical class put on by Marshal Appelhanz and wanted to report it was very well attended and she found a huge benefit and hopes we will continue to offer it.
- 5. Discussed mechanical issues with the 2015 Dodge Durango patrol car and let the Board know that it is an expense that will be in the financial report.
