Trustee Melnikoff brought up Republic Services, our area's trash company, and how their rate raises are not conducive to our community members. There was mention of the Town looking into a Town wide contract with a trash service to offer trash removal as a town utility.

Town Manager brought up the issue regarding the local post office now charging a fee for in town residents to use their po boxes, which have been provided for free up until now. The postal Service is requiring residents to either pay to use their box or install a mail receptacle at their place of residence to receive their mail for no charge. As far as we know, at least two separate letters have gone out to residents, one of which claims that the Town making the alley behind the the post office a one way, now causes an issue where certain residents cannot receive mail at their physical location and are now REQUIRED to pay for a box. Town Manager is looking further into this matter.
