The Plateau Valley Historical Society does hereby give a letter of support to the Town of Collbran so it may pursue badly needed grants to improve the Town's Auditorium.

The Auditorium has been a staple of the community since it was built in the early 1900s, and now age and changing times necessitate extensive repair and modernization.

Dr. Zinke had it built in the early 1900s. He hired Coakley, Stephan Kendall, John Harris, and Ernie Winston, to construct it. The round roof rafters were built on the ground and then hoisted into place with two big hay derricks. It is 40x 120 feet and has hosted many events: meetings, memorials, dances, banquets, movies, roller skating, recreation, graduations, community meetings, plays, Chautauqua's, parties, literary debates, and The Stockmen's ball & banquet. The stage curtains were installed in 1905. Dr. Zinke purchased the first movie projector and the first movies were shown in 1914. On May 30, 1916, a comedy "Office 666" was shown. Before the auditorium was built the location was John Art Fitzpatrick's livery stable.

PVHPS strongly supports the Town's effort to "fix" the building and has a fund of \$2500 designated to assist the project.

As a long-time Collbran resident and former Mayor of the Town of Collbran, I would like to submit this letter of support the Collbran Auditorium Renovation.

During my tenure as Mayor, Town Staff worked diligently with the Plateau Valley Historical Society and Mesa County to have the Collbran Auditorium declared as Mesa County Historic Landmark #4. With funding from the State Historic Fund, the skilled team at Chamberlin Architecture completed a thorough Historic Structure Assessment that was completed in July 2019. Finally, with the invaluable assistance of the University Technical Assistance program at the University of Colorado Denver, the UTA team completed a Sentiment Function and Survey report. The key finding in the report summary was "The survey results indicate a strong sentiment around the presence of the Collbran Auditorium along with an appreciation for its value to the community and its history......Overall the survey sentiment leaned toward renovating the auditorium for viable community uses, while conserving its historic Main Street Character."

I believe the Town is now fully poised to deliver on that promise and to rehabilitate and preserve the Collbran Auditorium for now and for future generations. There is a strong management team and a commitment from the current Board of Trustees to move forward with this rehabilitation. The Team has developed a phased approach to break the project into manageable projects to fund and to administer. The Colorado Department of Local Affairs has provided additional support to the project by co-funding the design development phase of the project, and I am optimistic that the Town will receive funding from DOLA for construction.

I ask that you provide funding to help protect and preserve the Collbran Auditorium so that future generations will be able to enjoy this historical, beloved building.

Mesa County Government provides this letter of support for the Town of Collbran's application for Community Development Block Grant funding through the Colorado Department of Local Affairs for the Collbran Auditorium Renovation project.

The Mesa County Register of Historic Landmarks recognizes the historic, architectural, and cultural heritage of Mesa County with the goal of increasing the public's appreciation of Mesa County's unique heritage. Accordingly, the Board of County Commissioners unanimously designated the Collbran Auditorium as a Mesa County Historic Landmark Number 4 on June 20th, 2017. The Auditorium, which was constructed in 1907, has served as a focal point for the Collbran community for 115 years. It has been an important gathering place for cattlemen and wool growers, served as a dance hall and theatre, was at one time a roller-skating rink, and still has the projection booth from when it served as a movie theater. It remains to this day an important community gathering place for not just the residents of the Town of Collbran, but for many organizations and community groups throughout the Plateau Valley.

The Auditorium is in need of extensive rehabilitation and renovation to allow it to serve the community for another hundred years or more. With financial support from the Colorado State Historic Fund and the Colorado Department of Local Affairs, the Town has developed a plan to begin a multi-phased renovation project that will first address structural and life-safety issues and protect and preserve the exterior of this historic community center. Mesa County fully supports the Town's plan to rehabilitate the structure, and is committed to providing assistance from our building, planning, and engineering staff as the Town moves forward with this legacy project.

Mesa County values the importance of stabilizing and strengthening our neighboring communities, and the economy, by supporting programs that assist rural communities with technical assistance and subsequent grant relief to achieve these programs. Mesa County appreciates and looks forward to continuing to collaborate on opportunities to strengthen our community while providing resources for our citizens.
